## ALTERNATIVE LIST ELIGIBILITY REQUIREMENTS FOR ADMITTANCE TO LEISURE ARMS COMPLEX

Alternative List requirements for when Vacant Units are available, because no one on the Priority List has accepted an available unit.

- 1. Must be at least 62 years of age.
- 2. Be a continuous resident of the Township of Lower Alloways Creek for no less than the past year without a break. Requires proof of residency, see item 7.
- 3. Must have been a resident of the Township for a minimum of 10 years prior to moving away. Requires proof of residency, see item 7.
- 4. Will be placed on the Alternative List by using a combination of age in years plus number of years of current residency, plus 50% of the years of prior residency.
- 5. Can be placed on the list at any time during the year.
- 6 No additional points will be given for number of years on the Alternate list.
- 7. Proof of Residency requires:
  - a. One of the following: Driver's License, property tax bill, rental agreement, contract of sale, deed, or notarized letter from landlord with copy of tax bill; and
  - b. One of the following: utility bills, voter registration, or car insurance card.
  - c. The Township reserves the right to accept two proofs of residence not specifically designated above as proof within their sole discretion.
  - d. Any falsification of documents will result in a permanent ineligibility of the applicant.
