WHEREAS, it is the policy of Township of Lower Alloways Creek to treat employees and prospective employees in a manner consistent with all applicable employment laws and regulations including, but not limited to Title VII of the Civil Rights Act of 1964, as amended by the Equal Opportunity Act of 1972, the Age Discrimination in Employment Act, the Equal Pay for Equal Work Act, the Fair Labor Standards Act, the New Jersey Law Against Discrimination, the Americans with Disabilities Act, the Family and Medical Leave Act, the Conscientious Employee Protection Act, the Public Employee Occupational Safety and Health Act, (the New Jersey Civil Service Act,) (the New Jersey Attorney General's guidelines with respect to Police Department personnel matters,) the New Jersey Workers Compensation Act, the Federal Consolidated Omnibus Budget Reconciliation Act (COBRA) and the Open Public Meeting Act; and

WHEREAS, the Township Committee of the Township of Lower Alloways Creek has determined that there is a need for personnel policies and procedures to ensure that employees and prospective employees are treated in a manner consistent with these laws and regulations.

NOW, THEREBY, BE IT RESOLVED by the Township Committee of the Township of Lower Alloways Creek that the Personnel Policies & Procedures Manual and Employee Handbook is hereby amended as follows:

to change the Probationary Period from the now stating eight (8) months to be here forth twelve (12) months to be consistent with the Township Code, Chapter 40 Personnel Policies, Article I Working Conditions and Benefits, section 40.1.1 Introductory Period

BE IT FURTHER RESOLVED that these personnel policies and procedures shall apply to all Township officials, appointees, employees, volunteers and independent contractors. In the event there is a conflict between these rules and any collective bargaining agreement, personnel services contract or

ORDINANCE 2023-13

AN ORDINANCE AMENDING THE CODE OF THE TOWNSHIP OF LOWER ALLOWAYS CREEK, CHAPTER 43 POLICE DEPARTMENT, SECTION 5 KNOWN AS "QUALIFICATION FOR APPOINTMENT AND PROMOTION"

SECTION 1. The following section of the Township of Lower Alloways Creek Township Code is hereby amended: CHAPTER 43 POLICE DEPARTMENT, §43-5 A, known as "Qualification for Appointment and Promotion" to add a subsection g under part 1 requiring law enforcement officer to hold a valid Police License and under §43-5 B, known as "Promotions" to change "shall" to "may" in part 1 as follows:

§ 43-5. Qualification for Appointment and Promotion [Adopted 7-12-05 as Ord 2005-13; amended 2/3/09 as Ord 2009-01, 7/21/09 as Ord 2009-11, 8/18/2009 as Ord No. 2009-13, 01-16-204 as Ord 2023-13]

A. Qualifications for Appointment

- 1. Except as provided under N.J.S.A. 40A:14-122, all persons appointed as a member of the police department shall:
 - g. Pursuant to the provisions of the New Jersey Police Licensure Act, N.J.S.A. 52:17B-66 et seq., effective January 1, 2024, all current and future law enforcement officers employed by the Police Department of the Township of lower Alloways Creek must hold a valid, active license issued by the Police Training Commission (PTC) in order to be employed as a police officer in the State of New Jersey.

B. Promotions

1. The Township Committee, in consultation with the Director of Public Safety and Chief of Police, shall may consider the following criteria for evaluation of candidates for promotion. Candidates for promotion shall may:

SECTION 2. All Ordinances or parts of Ordinances inconsistent herewith to the extent of such inconsistencies be and the same are hereby repealed to the extent of such inconsistency.

SECTION 3. This Ordinance shall take effect upon its final passage and publication as required by law. The provisions of this Ordinance shall remain in full force and effect until amended or repealed.

- 6. Any tactics and techniques utilized in protecting the safety and property of the public, provided that their disclosure could impair such protection. Any investigations of violations or possible violations of the law.
- _____ 7. Any pending or anticipated litigation or contract negotiation other than in (4) above in which the public body is, or may become a party. Any matter falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer.
- ______8. Any matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance of promotion or disciplining of any specific prospective public officer or employee or current public officer or employee employed or appointed by the public body, unless all individual employees or appointees whose rights could be adversely affected request in writing that such matter or matters be discussed at a public meeting.
