#### ORDINANCE 2019-01

#### CALENDAR YEAR 2019 AN ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK IN ACCORDANCE WITH N.J.S.A. 40A:4-45.14

WHEREAS, the Local Government Cap Law, N.J.S.A. 40A:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the Lower Alloways Creek Township Committee of the Township of Lower Alloways Creek in the County of Salem finds it advisable and necessary to increase its CY 2019 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and

WHEREAS, the Lower Alloways Creek Township Committee hereby determines that a 3.5% increase in the budget for said year, amounting to \$ **362,774.00** in excess of the increase in final appropriation otherwise permitted by the Local Government Cap Law, is advisable and necessary; and

WHEREAS, the Lower Alloways Creek Township Committee hereby determines that any amount authorized herein above that is not appropriated, as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW, THEREFORE BE IT ORDAINED, by the Lower Alloways Creek Township Committee of the Township of Lower Alloways Creek, in the County of Salem, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2019 budget year, the final appropriations of the Township of Lower Alloways Creek shall, in accordance with this ordinance and N.J.S.A. 40A:4-45.14, be increased by 3.5%, amounting to **\$ 362,774.00**, and that the CY 2019 municipal budget for the Township of Lower Alloways Creek be approved and adopted in accordance with this ordinance; and

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriations in either of the next two succeeding years; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within five (5) days introduction; and

BE IT FURTHER ORDAINED that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director with five (5) days after such adoption.

Public Hearing on this Ordinance shall be on Tuesday, February 19, 2019 at 7:30 p.m., at the Municipal Building, 501 Locust Island Road, Hancock's Bridge, New Jersey.

This Ordinance which was introduced for First Reading on Tuesday January 15, 2019 shall be published by Title in the South Jersey Times and placed on the Township's Bulletin Board giving notice of said Public Hearing as required by Law.

# REPORTS TO THE COMMITTEE & COMMITTEE REPORTS:

# Public Works:

Superintendent Fogg stated that he had been talking with the County Engineer and he was unaware that Buckhorn Bridge had been closed. He wants to look into it, because he was involved in the repair of the deck the last time it was done.

Frainger engineering is still working with South State to have the punch list for the last section of Alloways Creek Neck Road which was paved taken care of. Superintendent Fogg sated that there are dips in the pavement and they tore up the side of the road in several places, which needs leveling and grass.

Superintendent Fogg stated that the Locust Island Sluice Gate needs repairing.

Superintendent Fogg stated the road leading to the State Ramp is washing out and needs several loads of rip/rap deposited on its edges to keep it from washing out across the road.

Superintendent Fogg also asked that the Committee approve a change order to include rear lights for the new Trash truck, he feels it's a safety issue to be able to see with the rear camera when it is dark.

## **Police Department:**

Chief Venable stated that the Department had come to an agreement with Car Fax to give them Accident Reports in exchange for providing links for the public to obtain said Accident Reports.

Chief Venable was asked by the Mayor to tell the Committee what recent mandate the Police Departments had been given by the State Attorney General. Chief Venable stated that the State Attorney General's Office had handed down an order that Local Police agencies should not let Federal Immigration Officials use their facilities or interview rooms with respect to any activity involving illegal immigrants. Chief Venable spoke with the Committee that he would like to see two Police Vehicles ordered, one which can be order with 2018 budget funds per the auditor and one from 2019 funds, as Ford is updating their vehicles and none will be available till this fall / winter. Chief Venable stated that one vehicle will be later than we normally get one and the other will be somewhat earlier than usual, but we won't get stuck with what is leftover and maybe not get one, if we wait till the fall.

## Fire Department: nothing at this time.

### **Mayor and Committee Members**

No one from the Committee had any additional comments.

Mayor Pompper stated that the Log cabin will be open on March 17<sup>th</sup> 1-4 PM.

**PUBLIC COMMENT:** Mr. Fisher commented that the County needs to look at the Salem Hancocks Bridge Road as it is in need of repairs, just after the Bridge heading north the road has sunk in places to the point it can jar the steering wheel in your hand when traveling over that area.

Mayor Pompper read a letter from Mrs. Patricia A. Willis resigning from the Township Committee, Mrs. Willis will be living in Florida more than New Jersey, but will be in the area until the first part of March. Mrs. Willis will then be away vacationing till April. Mrs. Willis stated that she has enjoyed working with the Committee, Clerk and CFO and has gained the knowledge of all the work that is done and lives touched that most people never know about or see. Mrs. Willis states that the Committee can replace her whenever it is felt it is convenient for the Committee.

<sup>4.</sup> Any collective bargaining agreement, or the terms and conditions which are proposed for inclusion in any collective bargaining agreement, including the negotiation of the terms and conditions thereof with employees or representatives of employees of the public body.

Any matter falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer.
