RESOLUTION AUTHORIZING THE TOWNSHIP OF LOWER ALLOWAYS CREEK THROUGH THE LOWER ALLOWAYS CREEK POLICE DEPARTMENT TO PARTICIPATE IN THE DEFENSE LOGISTICS AGENCY, LAW ENFORCEMENT SUPPORT OFFICE, 1033 PROGRAM TO ENABLE THE LOWER ALLOWAYS CREEK POLICE DEPARTMENT TO REQUEST AND ACQUIRE EXCESS DEPARTMENT OF DEFENSE EQUIPMENT

WHEREAS, the United States Congress authorized the Defense Logistics Agency (DLA) Law Enforcement Support Office (LESO) 1033 Program to make use of excess Department of Defense personal property by making that personal property available to municipal, county and State law enforcement agencies (LEAs); and

WHEREAS, DLA rules mandate that all equipment acquired through the 1033 Program remain under the control of the requesting LEA; and

WHEREAS, participation in the 1033 Program allows municipal and county LEAs to obtain property they might not otherwise be able to afford in order to enhance community preparedness, response, and resiliency; and

WHEREAS, although property is provided through the 1033 Program at no cost to municipal and county LEAs, these entities are responsible for the costs associated with delivery, maintenance, fueling, and upkeep of the property, and for specialized training on the operation of any acquired property; and

WHEREAS, N.J.S.A. 40A:S-30.2 requires that the governing body of the municipality or county approve, by a majority of the full membership, both enrollment in, and the acquisition of any property through, the 1033 Program; and

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Lower Alloways Creek that the Lower Alloways Creek Police Department is hereby authorized to enroll in the 1033 Program for no more than a one-year period, with authorization to participate terminating on December 31 of the 2022 calendar year from January 1, 2022 to December 31, 2022 and

NOW THEREFORE BE IT FURTHER RESOLVED that Lower Alloways Creek Police Department is hereby authorized to acquire items of non-controlled property designated "DEMIL A," which may include office supplies, office furniture, computers, electronic equipment, generators, field packs, non-military vehicles, clothing, traffic and transit Signal systems, exercise equipment, farming and moving equipment, storage devices and containers, tools, medical and first aid equipment and supplies, personal protection equipment and supplies, construction materials, lighting supplies, beds and sleeping mats, wet and cold weather equipment and supplies, respirators, binoculars, and any other supplies or equipment of a non-military nature identified by the LEA, if it shall become available in the period of time for which this resolution authorizes, based on the needs of the Lower Alloways Creek Police Department without restriction; and

NOW THEREFORE BE IT FURTHER RESOLVED that Lower Alloways Creek Police Department is hereby authorized to acquire the following "DEMIL B through Q" property, if it shall become available in the period of time for which this resolution authorizes: {specifically list controlled property items authorized for acquisition of including quantity, e.g.1 (1) utility truck, (12) 5.56 millimeter rifles, or (1) MRAP, etc.]; and

BE IT FURTHER RESOLVED that the Lower Alloways Creek Police Department shall develop and implement a full training plan and policy for the maintenance and use of the acquired property; and

BE IT FURTHER RESOLVED that the Lower Alloways Creek Police Department shall provide a quarterly accounting of all property obtained through the 1033 Program which shall be available to the public upon request; and

BE IT FURTHER RESOLVED that this resolution shall take effect immediately and shall be valid to authorize requests to acquire "DEMIL A" property and "DEMIL B through Q" property that may be made available through the 1033 Program during the period of time for which this resolution authorizes; with Program participation and all property request authorization terminating on December 31st of the 2022 calendar year from January 1, 2022 to December 31, 2022.

WHEREAS, the Annual Report of Audit for the year ending December 31, 2020 has been filed by a Registered Municipal Accountant with the Township Clerk pursuant to N.J.S.A. 40A:5-6, and a copy has been received by each member of the governing body; and

WHEREAS, R.S. 52:27BB-34 authorizes the Local Finance Board of the State of New Jersey to prescribe reports pertaining to the local fiscal affairs; and

WHEREAS, the members of the governing body have personally reviewed as a minimum the Annual Report of Audit, and specifically the sections of the Annual Audit entitled "Findings and Questioned Costs" or "Findings and Recommendations", as evidenced by the group affidavit form of the governing body attached hereto; and

WHEREAS, such resolution of certification shall be adopted by the governing body no later than

forty-five days after the receipt of the annual audit, pursuant to N.J.A.C. 5:30-6.5; and

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

WHEREAS, failure to comply with the regulations of the Local Finance Board of the State of New Jersey may subject the members of the governing body to the penalty provisions of 52:27BB- 52 -to wit:

R.S. 52:27BB-52 -A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his/her office. "

WHEREAS, the Township of Lower Alloways Creek requires Professional Engineering/Consulting Services for the Wireless Telecommunications Tower Project; and

WHEREAS, this award of contract will provide professional engineering/consulting services which will include Site Visits, Review of Site Plan, Prepare recommendations of options, preparation of Bid Specifications for a telecommunications tower and review the bids received for the Wireless Telecommunications Tower project; and

WHEREAS, such award of contract shall be made as a non – fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.5; and

WHEREAS, Kevin S Clour, the Township Chief Financial Officer has determined and certified in writing that the value of the acquisition will not exceed \$17,500.00; and

WHEREAS, the anticipated term of this contract is one year; and

WHEREAS, VCOMM Telecommunications Engineering has provided a Business Entity Disclosure Certification to the Township, prior to the adoption of this Resolution, which certifies that VCOMM Telecommunications Engineering (including any individual with an ownership "interest" or control of more than 10% of its profits or assets or 10% of its stock, if a corporation,

or any of its principals, partners, officers or directors or their spouses) has not made any reportable contributions to a political or candidate committee in the members of the Lower Alloways Creek Township Committee, it being understood that the contract will prohibit VCOMM Telecommunications Engineering from making any reportable contributions, contrary to N.J.S.A. 19:44A-20.5, through the term of their contract with the municipality; and

WHEREAS, VCOMM Telecommunications Engineering has submitted a New Jersey Business Registration Certificate prior to the adoption of this Resolution; and

WHEREAS, VCOMM Telecommunications Engineering has completed and submitted to the Township, the necessary documents in accordance with the New Jersey Local Unit "Pay to Play" Laws (N.J.S.A. 19:44A-20.4 et. seq.): WHEREAS, pursuant to the New Jersey Local Unit "Pay to Play Law, N.J.S.A. 19:44A 20.4 et seq., the Township has sought qualified professionals, namely New Jersey licensed 18 - 05 - 07 – 124 engineers and surveyors, to provide the services through the use of a "non-fair and open process," as defined in N.J.S.A. 19:44A-20.7; and

WHEREAS, the Township Committee deems it in the best interests of the Township to award a Contract to VCOMM Telecommunications Engineering to provide the services delineated in the proposal and wishes to provide its approval to the award of contract; and

WHEREAS, the availability of funds has been certified by Kevin S Clour the Chief Financial Officer who shall make an appropriate entry into the Township's encumbrance system pursuant to N.J.A.C. 5:30-5.1 and 5.2 prior to the issuance of a contract; and

WHEREAS, the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq., requires that the resolution authorizing the award of contracts for "Professional Services" without competitive bidding must be publicly advertised. NOW, BE IT FURTHER RESOLVED, by the Township Committee of the Township of Lower Alloways Creek that a Professional Services Contract be awarded and executed with VCOMM Telecommunications Engineering to provide the aforementioned engineering/ consulting services reflected in the proposal for the sum of \$17.500.00 which includes Site Visits, Review of Site Plan, Prepare recommendations of options, preparation of Bid Specifications for a telecommunications tower and review the bids received for the Wireless Telecommunications Tower project;

BE IT FURTHER RESOLVED that the Business Disclosure Entity Certification, Determination of Value Certification, Political Contribution Disclosure Form and Stockholder Disclosure Certification referenced above be placed on file with this resolution;

BE IT FURTHER RESOLVED, that Timothy W. Bradway, Mayor and the Township Clerk are hereby authorized to execute the contract and any and all related documents reflected in the proposal with VCOMM Telecommunications Engineering to take any and all actions necessary to complete and realize the intent and purpose of this Resolution;

BE IT FURTHER RESOLVED, that the compensation to be paid to VCOMM Telecommunications Engineering shall be based on the proposal submitted by VCOMM Telecommunications Engineering with the understanding that total compensation for

performance under the contract shall be \$17.500.00 for the described tasks and may be exceeded if other work outside of these parameters are agreed to.

REPORTS TO THE COMMITTEE & COMMITTEE REPORTS:

Police Department: Chief Venable reported that the Department does need to order a new vehicle, but the dealers are telling us that they do not know when the new models will be available. There was some discussion of grants for electric vehicles.

Public Works: Superintendent Fogg stated that the New Recycling Truck still has some issues to be worked on (back sticker, step, seat and door handle.

Superintendent Fogg stated that there had been problems with the Gas Pump vapor locking and not working, lines were changed to above ground by the Department and it is working now. The diesel lines will also need to be changed to above ground.

Superintendent Fogg stated that the County has a new Supervisor and they are making changes, two pieces of equipment may be sold a Road Grader and a Truck Tractor and Drop Trailer all of which we could use.

Fire Department: Chief Fisher stated that he is unsure what is going on about the Fire Hose as the company sent out a letter in June stating the price was going to increase and now they are not sure when it will be available.

PUBLIC COMMENT: No one from the Public indicated that they wished to make any comments.

Mayor and Committee Members

Mr. Collier asked if the Zoning and Construction had been asked to inform the Committee if they were having problems with anyone or properties. The Clerk stated that they had.

Mrs. Crane stated that the Log Cabin will have the next Open Hose on September 18th.

Mr. Venable asked the solicitor what the liability might be for asking residents if they have any excess vegetables from their gardens to take it to the Senior Lunch so seniors could go get it and take it home. The Solicitor suggested it would not be a good idea for the Township to get involved in.

Mayor Bradway stated that he had been asked by the Quinton Mayor if the Coalition would consider letting Quinton Join. Mayor Bradway stated that it would mean two more days to pick up Quinton and there is only one day open which is Fridays. Mayor Bradway also stated that we would need to get another trash truck and hire another person. The Committee discussed the idea and agreed it would be too much additional work to handle easily.

Any material the disclosure of which constitutes an unwarranted invasion of individual privacy such as records, data, reports, recommendations, or other personal material of any educational, training, social service, medical, health, custodial, child protection, rehabilitation, legal defense, welfare, housing, relocation, insurance and similar program or institution operated by a public body pertaining to any individual admitted to or served by such institution or program, including but not limited to information relative to the individual's personal and family circumstances, and any material pertaining to admission, discharge, treatment, progress or condition of any individual, unless the individual concerned (or, in the case of a minor or incompetent, his guardian) shall request in writing that the same be disclosed publicly.
- _____ 6. Any tactics and techniques utilized in protecting the safety and property of the public, provided that their disclosure could impair such protection. Any investigations of violations or possible violations of the law.
- 7. Any pending or anticipated litigation or contract negotiation other than in (4) above in which the public body is, or may become a party. Any matter falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer.
- _____ 8. Any matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance of promotion or disciplining of any specific prospective public officer or employee or current public officer or employee employed or appointed by the public body, unless all individual employees or appointees whose rights could be adversely affected request in writing that such matter or matters be discussed at a public meeting.

More specifically, the matter to be discussed involves the following:

1. Personnel

BE IT FURTHER RESOLVED, that the matters discussed will be available for public inspection

1. At such time the matter is concluded

BE IT FURTHER RESOLVED that this Resolution shall take effect immediately.

BE IT FURTHER RESOLVED that this Closed Session is expected to continue for fifteen (15) minutes and there after the regular meeting would then reconvene and further business by the Committee may take place at its conclusion.
