AWARDING A CONTRACT TO "R" BUTTONWOOD FARM, LLC FOR THE LEASE OF TOWNSHIP LAND FOR FARMING PURPOSES FROM JANUARY 1, 2023 THROUGH DECEMBER 31, 2025

WHEREAS, the Township of Lower Alloways Creek desires to lease certain public property for farming purposes and;

WHEREAS, the Township had previously authorized the Purchasing Agent to advertise such specifications necessary to receive bids for such farm ground lease, and;

WHEREAS bids have been received and opened at the advertised date and time, and;

WHEREAS, "R" Buttonwood Farm, LLC of Hancocks Bridge, New Jersey submitted the highest lease bid amount of two thousand five hundred ninety—two dollars (\$ 2,592.00) for the entire length of the three (3) year contracting period, and;

WHEREAS, the Purchasing Agent of the Township is recommending a contract be awarded to "R" Buttonwood Farm, LLC.

NOW, THEREFORE BE IT RESOLVED that the Township Committee of the Township of Lower Alloways Creek does hereby award a three (3) year contract to "R" Buttonwood Farm, LLC of Hancocks Bridge, New Jersey to lease the public property describe below for farming purposes from January 1, 2013 through December 31, 2025 to the Township as follows:.

- **A.** Use of Property: the Tenant's use of the property is restricted exclusively to farmland use and no other use shall be permitted.
- **B. Description of Property:** The property that is the subject of this Lease is identified on the Lower Alloways Creek Township Tax Map as Block 16, Lot 22, consisting of approximately 12.80 acres, Block 19, Lot 9.01, consisting of approximately 1.85 acres and Block 19, Lot 9.02 consisting of approximately 2.61 acres (17.26 acres total more or less).
- C. Purpose: the Tenant shall use said leased premises for farming purposes only and shall plant a cover crop of at least two (2) bushels of barley or wheat per acre on the entire premises to germinate prior to the termination of the Lease. The Tenant shall have no right to harvest said cover crop or any growing crop from the property after December 31, 2025
- **D.** Entry by Landlord: the Landlord reserves the right to enter the premises during the term of the Lease to mow the ditches in such a manner as to not damage crops on the property.
- **E.** Exclusion from Lease: the site of the old creamery on said property shall be excluded from this Lease.

The Township Committee had a report from the JIF of a safety inspection done on the Hancocks Bridge playground equipment. ## REPORTS TO THE COMMITTEE & COMMITTEE REPORTS:

#### **Public Works:**

Superintendent Fogg stated that he had worked 42 years and four months for the Township and was looking forward to his retirement on December 31<sup>st</sup>.

## **Police Department:**

Chief Venable stated that the Department recently had a call for a suicidal person with a gun and the responding Officers were able to deescalate the situation and get the person in custody without incident.

Chief Venable stated that both he and Sgt. Carlson had completed more of their Emergency Management Training recently and had only a few courses left to complete their training.

## **Mayor and Committee Members**

Mr. Collier stated that he had called Bert Lopez from Atlantic City Electric hoping not to get rusty steel electric poles to the Wind Port, but was told the process of using them was already in progress.

Mr. Collier commented that the traffic light at New Bridge when approaching Harmersville Pecks Corner Road takes a very long time to change and the camera seems to be pointed down too far. Superintendent Fogg stated that he had the County look into that very situation and the NJDOT who services the lights, stated that everything is fine.

Ms. Crane stated that on January 12 at 7:00 pm there will be a Historical Committee Meeting at the Senior Lunch Facility.

Mr. Venable wished everyone a Happy New Year and Merry Christmas.

Mr. Palombo stated that at the recent TOLACEMO Trash Coalition Meeting none of the participating municipalities wanted to bring in any new members, because of scheduling and maintenance issues.

Mayor Bradway stated that he participated in a Wind Port online meeting and they stated that piles would be driven in starting in January and continuing through March, both on land and in the river. The wind port has about 100 employees working currently.

Any matter falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer.

Any matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance of promotion or disciplining of any specific prospective public officer or employee or current public officer or employee employed or appointed by the public body, unless all individual employees or appointees whose rights could be adversely affected request in writing that such matter or matters be discussed at a public meeting.
