# **BUDGET SESSION**

Mayor Pompper called on the different Departments to speak with the Committee about their Capital Budget wants.

LAC School: Mrs. Dubois-Brody spoke for the local school and there need for a new Generator, 54 passenger buses, a 15 passenger van and a current need of a special needs bus w/ handicapped ramp. (\$650,000)

## Fire Company:

Chief Fisher spoke with the Committee about getting a new G3 aluminum boat and getting rid of the largest boat the department has. (\$3,600)

# Police Department:

Chief Venable spoke of the need for a new computer server. (\$23,000.00)

### Public Works:

Mr. Fogg reviewed with the Committee his Public Works capital item wish list.

Some of those items requested are: truck Lift, Boom Mower, Brown Trash Containers, Concrete to finish the Wash Bay, Safety related equipment, replace roofing on the Leisure Arms Kitchen and a new air compressor. (\$442,200.00)

## Administration:

Wide format scanner to digitize maps, construction drawings, other various items that are larger than  $11 \, \mathrm{X}$  17 which the current copies will go up to.

The Township Committee reviewed the revenue and appropriation budget information supplied by Kevin Clour the Chief Financial Officer and discussed the 2020 Municipal Budget and Capital Budget.

When discussing the Capital Budget the Committee recommended that an ordinance be prepared for \$202,000.00 under Administration, Public Safety& Public Works Equipment and \$105,000.00 for a special needs w/ handicapped ramp bus for the school.

PUBLIC COMMENT: No one from the public indicated that they wished to make any further comments.
