

**MINUTES OF A SPECIAL BUDGET MEETING OF THE TOWNSHIP COMMITTEE

A Special Meeting of the Lower Alloways Creek Township Committee was held on Tuesday March 1, 2022 with Mayor Timothy W. Bradway calling the meeting to order at 6:00 p.m.

**STATEMENT OF NOTICE GIVEN**

**RESOLUTION 2022-41  
AUTHORIZING EMERGENCY TEMPORARY APPROPRIATIONS**

WHEREAS, the Township Committee of the Township of Lower Alloways Creek does have need of making Emergency Temporary Appropriations to ensure the Function and Services of the municipality until the 2022 Budget is adopted, and;

WHEREAS, *N.J.S.A. 40A:4-20* allows for the addition of Emergency Temporary Appropriations for lawful purposes, for the period between the beginning of the budget year and the date of the adoption of the budget, and;

WHEREAS the Township of Lower Alloways Creek does have need of Emergency Appropriations until the 2021 Budget is finally adopted.

Mayor Bradway and the Committee discussed the capital items the different departments had requested and finalized what they would approve as follows:

School - \$ 32,200.00 for an Oven & flooring. The Committee will look into repaving the entrance way to the school.

Fire Dept.- \$ 98,000.00 for Air Packs and Fire Hose

Public works / Buildings & Grounds - \$ 57,000.00 for HVAC at Leisure Arms Units & Police Dept., re-single Leisure Arms roofs, re-paint pole shed roof and a carport type structure for the Bulk Container at the PW Convenience Center.

Administration - \$ 6,000.00 for three new computers
