## **Police Department:**

Chief Venable stated that Officer Young is still out and is not expected back for at least a Month, which is the cause for high overtime hours.

Chief Venable stated that the Department is waiting for the new car, which is expected to be delivered in the next couple of months.

Chief Venable stated that last week a vehicle was damaged while aiding Salem City, there was cosmetic damage to the rear bumper. No repairs will be made.

## **Fire Department:**

Chief Fogg stated that he had a meeting recently with the Wind Port people and our approval for Fire Hydrants were brought up. Chief Fogg will need to look into this.

Chief Fogg would like the Township to look into getting Error and Omissions (liability) insurance for the Fire Officers, to protect them when making firefighting related decisions. Chief Fogg stated that the Department would like to fund raise this year. Mr. Venable asked what did they needed that was not taken care of by the Township's budget for the Fire Company. Chief Fogg responded that there were items they did not fit into the budget's expenses.

Mr. Venable stated that there is a Ruritan Country Breakfast coming up in February.

Mr. Palombo stated that he has a County Ambulance Meeting this Thursday the 19<sup>th</sup>.

Mayor Collier stated that PSEG reported that Salem Unit 2 refuel begins about April 1<sup>st</sup> and the updated evacuation drill was sent to the State for review and that review can take up to 180 days.

Salem County Local Government has asked that we switch hosting months with Mannington, which would make our month December of this year.

Mayor Collier also stated that he has been asked for the Committee to look into getting internet for the Senior Lunch and improved internet service at the Public Works Department.

Randy Garrison, 319 Salem Hancocks Bridge Road, Mr. Garrison asked if the Township would be willing to sell or auction the 34 Second St. property, he would like to buy the property and fix it up. Mayor Collier stated that might be a possibility, we would need to find out what the process to do that is.

Any matter falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer.

Any matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance of promotion or disciplining of any specific prospective public officer or employee or current public officer or employee employed or appointed by the public body, unless all individual employees or appointees whose rights could be adversely affected request in writing that such matter or matters be discussed at a public meeting.
