WHEREAS, the Township of Lower Alloways Creek wishes to a purchase one Fire Fighting Vehicle from an authorized vendor under the State of New Jersey Contract 86453 and,

WHEREAS, Sutphen Corporation has been awarded New Jersey State Contract 86453 for certain Fire Fighting Vehicles through November 30, 2019; and

WHEREAS, the Municipal Engineer and Purchasing Agent are recommending that the base bid of \$156,033.00 be accepted and that a contract be awarded to South State, Inc., of Bridgeton New Jersey for \$156,033.00.

WHEREAS, the Solicitor is recommending that the bids be rejected for the replacement of the air conditioning unit(s) at the Hancocks Bridge Fire House and Kitchen/Dining areas project as the lowest bid was not responsive and the other bids exceeded the estimate.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Lower Alloways Creek in the County of Salem, State of New Jersey, that all bids received for the replacement of the air conditioning unit(s) at the Hancocks Bridge Fire House and Kitchen/Dining areas project are hereby rejected, and

# **ORDINANCE 2019-06**

AN ORDINANCE AMENDING THE CAPITAL BUDGET OF THE TOWNSHIP OF LOWER ALLOWAYS CREEK AND AUTHORIZING CAPITAL APPROPRIATIONS IN THE TOTAL AMOUNT OF ONE HUNDRED THOUSAND DOLLARS (\$160,000.00) FOR THE PURPOSE OF RESURFACING ALLOWAYS CREEK NECK ROAD.

BE IT ORDAINED BY THE, Township Committee of the Township of Lower Alloways Creek (not less than two-thirds of all the members thereof affirmatively concurring) as follows:

Section 1. One hundred sixty thousand dollars (\$160,000.00) is hereby appropriated from the Capital Improvement Fund for the purpose of the resurfacing of Alloways Creek Neck Road and hereby added to previous appropriations under Ordinance 2017-05 (\$300,000.00), 2015-02 (\$50,000.00), 2014-12 (\$120,000.00) & 2012-06 (\$470,000.00) as temporary funding till the expected grant funds from the NJDOT is received.

Section 2. The Capital budget of the Township of Lower Alloways Creek is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistencies herewith. Detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services shall be on file with the Clerk and available there for public inspection.

Section 3. This ordinance shall take effect as provided by the law.

Public Hearing on this Ordinance shall be on Tuesday July 16, 2019 at 7:30 p.m., at the Municipal Building, 501 Locust Island Road, Hancock's Bridge, New Jersey.

This Ordinance which was introduced for First Reading on June 18, 2019 shall be published by Title in the South Jersey Times and placed on the Township's Bulletin Board and official website giving notice of said Public Hearing as required by Law.

Chief Fisher stated that LAC will be standby at the County Fair one of the days, there are several more new members joining and the Department is having a Chicken BBQ on August 17<sup>th</sup>.

Chief Fisher stated that he has handed to each Committee Member a letter from the State Fire Marshall's Office representative stating that he is satisfied with the progress of the Department toward training and documentation thereof. Chief Fisher stated that there had been a complaint to the NJSFM office pertaining to training, records and personal protection equipment, which as far as he is concerned has been found to be false by the Regional Fire Coordinators letter.
