- Section 2. That seventy-eight thousand dollars (\$ 78,000.00) is hereby appropriated from the Capital Improvement General Fund for the purpose of acquiring School Materials
- Section 3. The Capital budget of the Township of Lower Alloways Creek is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistencies herewith. Detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services shall be on file with the Clerk and available there for public inspection.

**Police Department:** Chief Venable spoke about the new Part Time Officer, as one has now completed his "ride with" training and is on the road himself and the newest Part time Officer has started his "ride with" training with several Officers.

**Fire Department:** Chief Fisher mentioned that the Muskrat take-out dinner went well and the department could make suggestions on how the Ruritans could handle such a fundraiser.

- \_\_\_\_\_ 7. Any pending or anticipated litigation or contract negotiation other than in (4) above in which the public body is, or may become a party. Any matter falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer.
- \_\_\_\_\_\_8. Any matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance of promotion or disciplining of any specific prospective public officer or employee or current public officer or employee employed or appointed by the public body, unless all individual employees or appointees whose rights could be adversely affected request in writing that such matter or matters be discussed at a public meeting.

More specifically, the matter to be discussed involves the following:

1. Contracts and Possible Litigation

BE IT FURTHER RESOLVED that this Resolution shall take effect immediately.
