The LAC Twp School CSA Susan Schaffer introduced the Student Council who read prepared statements on some of the things going on in the school, an 8th grade student Allison spoke about new programs such as "H E R O S" helping everyone respect others, last year it was "kindness rocks" where students are encourage to be kind to one another and recognized when then do, Emily a 3rd grader spoke about the Muskrat reward program, Kylie a 5th grader spoke about how the PTO has help setup a school store, GAA GAA ball pit and a Four Square game, another student talked about after school clubs, which brought back the Student Council.

Walt Sheets, Board Member spoke about the reduction in state aid in recent years (\$169,000.00)

The school is in need of a van, special Ed bus (2020) (\$25,000.00), Handicapped capable bus (\$107,000.00) 54 passenger buses (\$135,000.00 each) need replacing in 2023-2025-2027. In addition a generator from the 70's needs to be replaced. Some students have been kept local instead of placed out of district and we are cooperating with other districts to reduce costs.

CSA Susan Schaffer and the Mayor discussed the study that will be taking place shortly which is to look at consolidating school districts.

Any matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance of promotion or disciplining of any specific prospective public officer or employee or current public officer or employee employed or appointed by the public body, unless all individual employees or appointees whose rights could be adversely affected request in writing that such matter or matters be discussed at a public meeting.
