A RESOLUTION CERTIFYING THE 2018 AUDIT

WHEREAS, the Annual Report of Audit for the year ending December 31, 2018 has been filed by a Registered Municipal Accountant with the Township Clerk pursuant to N.J.S.A. 40A:5-6, and a copy has been received by each member of the governing body; and

WHEREAS, R.S. 52:27BB-34 authorizes the Local Finance Board of the State of New Jersey to prescribe reports pertaining to the local fiscal affairs; and

WHEREAS, the Local Finance Board has promulgated N.J.A.C. 5:30-6.5, a regulation requiring that the governing body of each municipality shall by resolution, certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled "Findings and Questioned Costs" or "Findings and Recommendations; and

R.S. 52:27BB-52 -A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his/her office.

Mayor Pompper commented that the Danny Mitchell was a great help and worker at the last Log Cabin open house, this past Sunday.

No other Committeeman had any additional comments.

PUBLIC COMMENT:

Polly Ingram commented that the Senior Lunch Program needs to provide more nutritious food choices, with less sugars and that seniors cannot survive on Costco (Sysco) products.

Gail Donelson gave a list of School activities and up and coming events. New behavioral programs which is going well, which has allowed the district to keep three students within the district rather than transferring them out of district.

The Pre k has been well received and because of the number signed up a second class was added, an additional teacher was hired who has a special education certification allowing one student to remain in district.

A new reward program has begun called "Our Super Hero" based on helping and respecting others. This has been well received by Students, Staff and Parents, students are highlighted for the good deeds they do and recognized for it.

We have instituted the Muskrat Reward System, which has created a great discussion among students, parents and teachers, student focus on creating goals for academics, behavior and attendance in order to receive rewards at the end of the marking period.

The Muskrat mascot is back as well.

A training class will be hosted on September 26 focusing on "You are the help till help arrives", information will be given about what to do until emergency responders arrive.

A wellness committee was formed to focus on the students and staffs mental and physical health

Mayor Pompper thanked Mrs. Donelson for the report and stated that she is sure someone from the Township Committee could attend the School Board Meeting if there was a need for it.

Rose Kite asked the Committee if there were any efforts being made to get better cell phone service in LAC Twp.

Mayor Pompper and the Clerk responded the different ways the Committee has tried to get a provider to setup a cell tower in the community, but the low population, economics and changing technology have kept providers from coming to our area. Mr. Bradway mentioned that we had given Verizon authorization to place Network Nodes, which are short range cell signal repeaters, but are not aware that they have installed any.

Any pending or anticipated litigation or contract negotiation other than in (4) above in which the public body is, or may become a party. Any matter falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer. More specifically, the matter to be discussed involves the following: 1. Potential Litigation Notice of Tort Claim BE IT FURTHER RESOLVED, that the matters discussed will be available for public inspection 1. At such time the matter is concluded BE IT FURTHER RESOLVED that this Resolution shall take effect immediately.
