A Regular Meeting of the Lower Alloways Creek Township Committee was held on September 21, 2021 with Mayor Ellen B. Pompper calling the meeting to order at 7:30 p.m.

### WIND PORT

Mayor Pompper called on Brian Sabina, Senior Vice President of Economic Transformation for the New Jersey Economic Development Authority (NJEDA) to give the Committee and the public an overview of the Wind Port and recent activities.

Mr. Sabina began by stating that the Wind Port would be a purpose built place to assembly the 600 foot wind turbine poles and load them onto the installation vessels, where they would then be taken out to the areas 30 miles or so off shore where wind power leases have been determined and place them in the sea bed. The electric generating turbines would be staged at the port and then taken to be placed on the 600 foot poles off the shore. The manufacture of the turbines and blades would be done at this port and the one at Paulsboro.

Mr. Sabina stated that the first phases of construction which would be the dredging and site preparation would begin in the coming months. Mr. Sabina emphasized that the Governor is committed to having a diverse group employed on the project including women, minorities and small businesses for the projected 1500 people who potentially could be employed there. Mr. Sabina stated that as of now approximately 257 million dollars has been committed to this project because it is felt that its location (with no bridge height obstructions, proximity to navigable waters) and the available land area make it a unique and desireable place have wind turbine facilities. Mr. Sabina stated that closer to the second half of 2024 is when the Wind Port really begins to start it intended purpose.

Mayor Pompper opened the floor up for anyone to ask questions of Mr. Sabina about the Wind Port.

### Ouestions included:

How would this effect the roads with the increase in traffic and heavy vehicles of another 1500 people using them? Mr. Sabina stated that infrastructure was looked at and that the 1500 would not be until 2030 or so and would be in shifts, so not all be on the roads at one time. As far as the roads, yes they would be travelled and need maintenance and that would be taken care of by the means they are now (NJDOT planning & grants).

How will the dredging effect the fish, fisherman or the environment? Mr. Sabina stated that an environmental study has been done and it was determined that the area to be used was not a significant habitat for any fish or shellfish and in fact the sand dredged will be used to enhance habitats for marine life in other areas.

Will the vessels used be a hazard or impede local boats from area marinas? Mr. Sabina stated that bay and river traffic was also studied and it was determined that the vessels utilizing the Wind Port did not add significantly to the amount of traffic on the waterway now.

Have the bridges been inspected recently, underneath Hancocks Bridge seems to be cracking apart?

Mayor Pompper stated that all our bridges are County Bridges and they are responsible for them. The County is required by law to have all bridges inspected.

Residents expressed concern that there are only so many ways out of town and that New Bridge and the bridge on Buckhorn road have been closed and there does not seem to be any hope of having them replaced or repaired.

Mayor Pompper stated that she agrees, but it is a County issue and they do not seem to want to fix them.

Mayor Pompper asked if there were any more questions, if not there will be a 10 minute recess after which the Committee would continue with their regular business meeting.

Mr. Venable joined the meeting via a telephone placed on the Committee dais.

# A RESOLUTION CERTIFYING THE 2020 AUDIT

WHEREAS, N.J.S.A. 40A:5-4 requires the governing body of every local unit to have made an annual audit of its books, accounts and financial transactions; and

WHEREAS, the Annual Report of Audit for the year ending December 31, 2020 has been filed by a Registered Municipal Accountant with the Township Clerk pursuant to N.J.S.A. 40A:5-6, and a copy has been received by each member of the governing body; and

WHEREAS, R.S. 52:27BB-34 authorizes the Local Finance Board of the State of New Jersey to

prescribe reports pertaining to the local fiscal affairs; and

WHEREAS, the Local Finance Board has promulgated N.J.A.C. 5:30-6.5, a regulation requiring that the governing body of each municipality shall by resolution, certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled "Findings and Questioned Costs" or "Findings and Recommendations; and

WHEREAS, the members of the governing body have personally reviewed as a minimum the Annual Report of Audit, and specifically the sections of the Annual Audit entitled "Findings and Questioned Costs" or "Findings and Recommendations", as evidenced by the group affidavit form of the governing body attached hereto; and

WHEREAS, such resolution of certification shall be adopted by the governing body no later than forty-five days after the receipt of the annual audit, pursuant to N.J.A.C. 5:30-6.5; and

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

WHEREAS, failure to comply with the regulations of the Local Finance Board of the State of New Jersey may subject the members of the governing body to the penalty provisions of 52:27BB- 52 -to wit:

R.S. 52:27BB-52 -A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his/her office.

NOW, THEREFORE BE IT RESOLVED, that the Township Committee of the Township of Lower Alloways Creek, hereby states that it has complied with N.J.A.C. 5:30-6.5 and does hereby submit a certified copy of this resolution and the required affidavit to said Board to show evidence of said compliance.
